We work toward this goal by coordinating national, regional, and global efforts of Religious to call on political leaders to take action for a just, equitable, and rights-based implementation of the [Sustainable Development Goals](#) (SDGs), the United Nations' Agenda for 2015-2030.

COP28 WHAT IS IT?

COP28 refers to the 28th Conference of the Parties (COP) to the United Nations Framework Convention on Climate Change (UNFCCC). At the annual climate COP, delegates from UN Member States come together to negotiate global goals to address climate change, such as limiting global temperature rise to 1.5 degrees Celsius, helping vulnerable countries adapt to the effects of climate change, and achieving net-zero emissions by 2050. Governments' representatives also present their national plans for contributing to the accomplishment of these goals and report on challenges, best practices, and progress.

In addition to delegates from UN Member States, COP28 also gathers climate-concerned leaders from civil society, indigenous groups, academia, younger generations, and the private sector to accelerate our collective response to the climate crisis. At COP28, all of these groups will collaboratively take stock of progress on the Paris Agreement and work toward actionable solutions.

Why is COP28 important?

Today, our planet suffers from the unprecedented impacts of climate change including extreme heat, devastating wildfires, catastrophic floods, and the drastic rising of sea levels. As a global community, we are falling behind in our climate ambitions, and as a result, we are rapidly approaching a dangerous precipice. We need to catalyze urgent action to preserve a livable climate, for all forms of life on Earth, and we must do it now!



Key Terminology

The following terms provide an important foundation for understanding the global-policy conversation on climate change. You will want to be familiar with them if you plan on participating in or following the discussions at COP28

UN Framework Convention on Climate Change (UNFCCC)

The UNFCCC outlines the legal framework and principles for international climate change cooperation. Its overarching goal is to reduce atmospheric concentrations of greenhouse gases and to desist from dangerous human interference with the global climate system. Click [here](#) to learn more.

Intergovernmental Panel on Climate Change (IPCC)

The IPCC is the United Nations body tasked with assessing the science related to climate change. It collects scientific, technical, and socio-economic data on the risks and impacts of climate change and produces reports to guide governments in an effective response to the crisis. Paris Agreement

The Paris Agreement is an international treaty, adopted in 2015, to address climate change. It marks a significant achievement in the global discourse as the first legally-binding agreement to unite a multitude of countries in a collective commitment to engage in ambitious efforts to tackle climate change and its impacts. Under the Paris Agreement, individual countries determine how much they will reduce their carbon emissions each year, and these plans are called [nationally determined contributions](#) (NDCs). Global Stocktake

The Global Stocktake is a process for countries and stakeholders to assess if they are collectively making the necessary progress towards achieving the goals of the Paris Agreement. Participants will evaluate where the world stands on climate action and support, identify the gaps, and collaborate to generate a better plan to accelerate climate action. The Global Stocktake takes place every five years, and the first iteration will conclude at COP28, with the intent to inform the next round of NDCs to be proposed by 2025. Sustainable Development Goal 13 (SDG13)

SDG13 is a commitment by the global community to combat climate change as an important part of the of the UN's overall Sustainable Development Agenda. It sets specific targets and indicators for measuring our progress in addressing climate change. Its placement in the Sustainable Development Agenda signals a recognition that environmental conservation is a pillar of progress for the international community and should be monitored and promoted alongside other measures of development. COP28 UAE Priorities

Transitioning to clean energy

The world must urgently accelerate the energy transition (a drastic reduction of carbon emissions by phasing out the demand for, and supply of, all fossil fuels) in order to limit global warming to 1.5° Celsius above pre-industrial levels. COP28 will emphasize fast tracking the energy transition, in an orderly, just and equitable manner.

Delivering on climate finance

Finance is a critical component of climate action. COP28 needs to deliver on previous promises to fund climate action (such as the Green Climate Fund). It must also establish new mechanisms for the sharing of funds, knowledge, and technology between countries in order to make ambitious climate action affordable, available, and accessible for the most vulnerable.

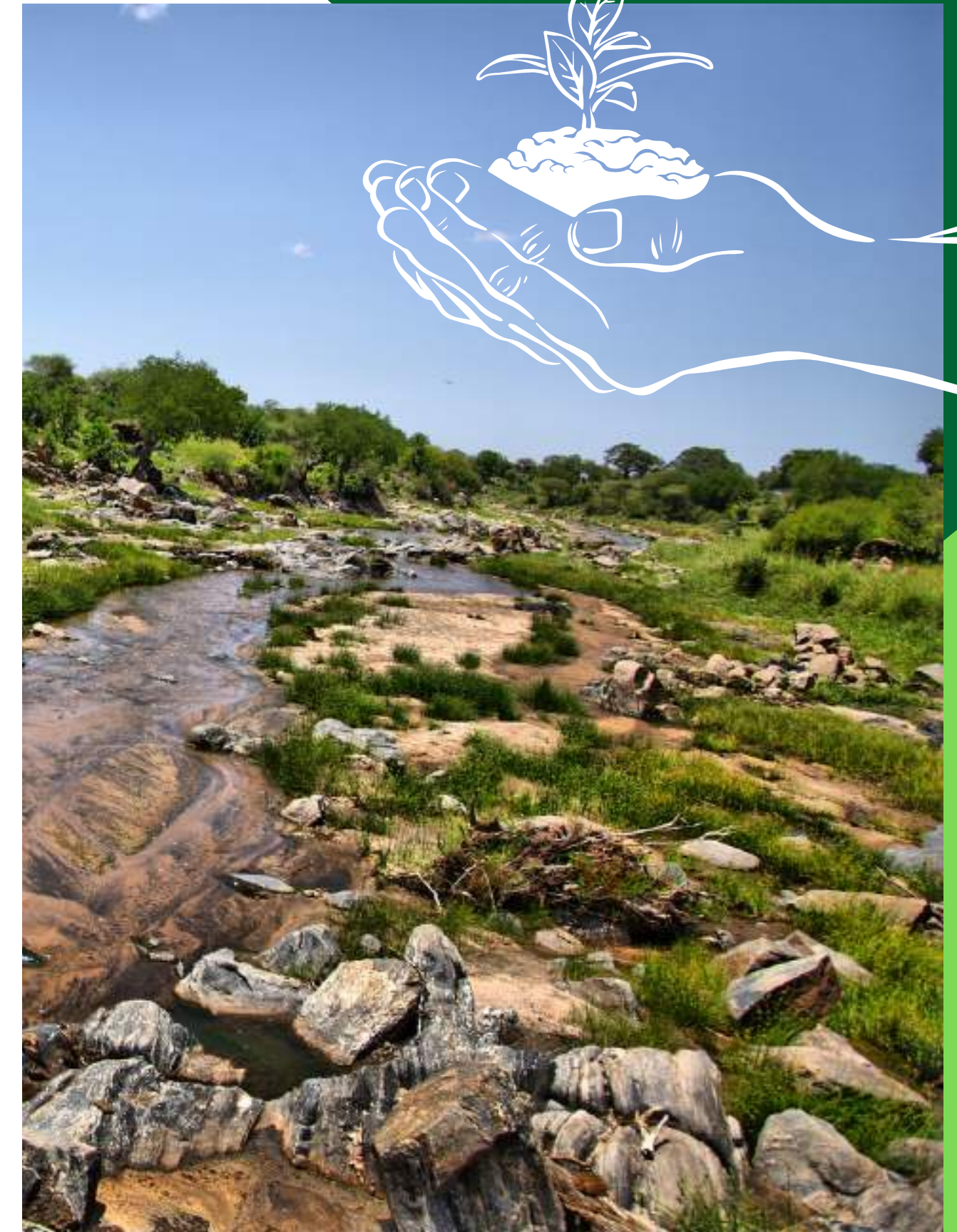
Centering nature, people, lives, and livelihoods

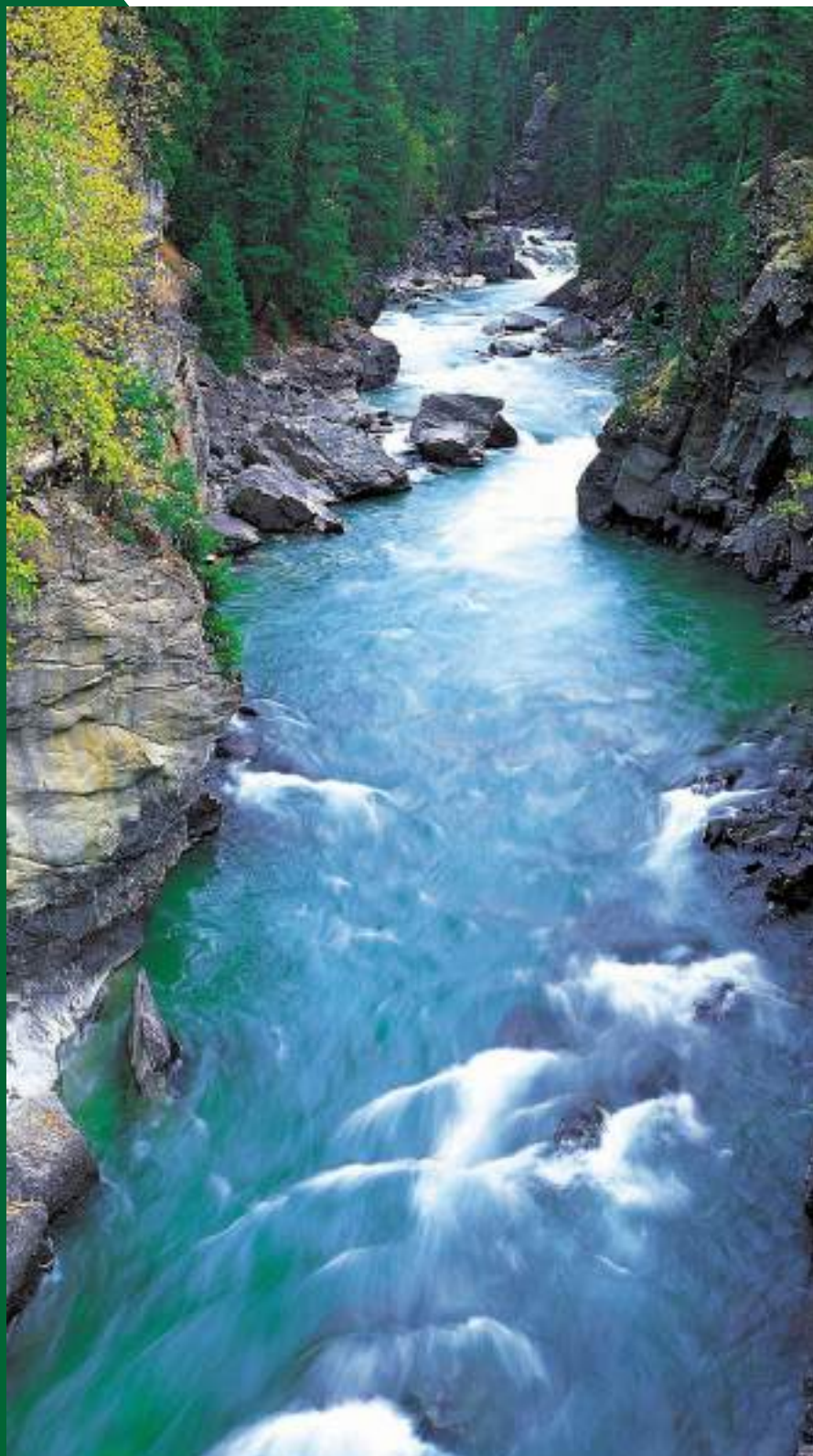
COP28 negotiations will strive to put nature, people, lives, and livelihoods at the heart of climate action, including by prioritizing the needs of the most vulnerable communities to adapt to the change that is already occurring. More specifically, this COP must move governments beyond commitments to practical support and recompense for the losses and damages suffered to the lives, property, and livelihoods as a result of climate change.

Mobilizing for the most inclusive COP

The United Arab Emirates (UAE), the government acting as the host and president of COP28, identified inclusion as a foundational principle of this conference. It described inclusion as a “tool that will enable us to collectively achieve ambitious outcomes at COP28.” Accordingly, the Presidency of COP28 aims to mobilize the most inclusive COP, ensuring that decisions and discussions, and how the solutions are implemented, are conducted in collaboration with Indigenous Peoples, youth, and climate-vulnerable communities.

- **Blue Zone:** This is the official plenary space of COP28. It is open to accredited government and observer delegates (individuals registered for COP28 who have an official COP28 access badge). The Blue Zone hosts the formal negotiations, the World Climate Action Summit, Pavilions, and hundreds of side events including panel discussions, round tables, and cultural events throughout the conference.
- **Green Zone:** This space is managed by the COP28 UAE Presidency. It provides a platform for non-accredited delegates, including global youth, civil society, indigenous groups, academics, and representatives from the private sector to engage in dialogue and promote awareness about climate action. 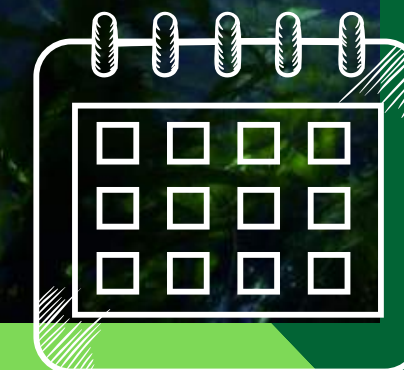

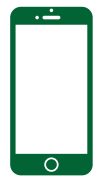
